Guaranteed Level Rates

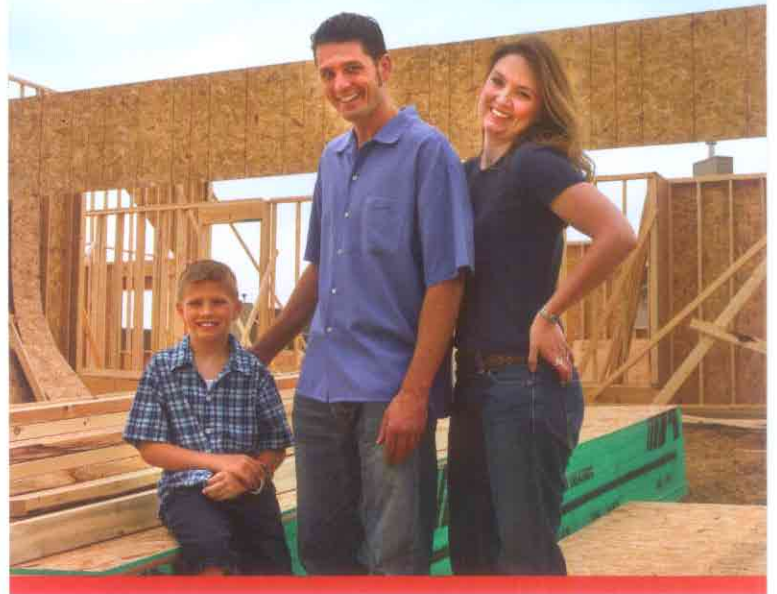
Catholic Knights term policyholders are guaranteed level rates for the length of the policy term, easing the uncertainty of fluctuations.

The “Living Benefit” allows policyholders to use a portion of their life insurance death benefit in certain situations. A terminally ill person with less than 12 months to live can access the death benefit before death. Also, the insurance policy can be used to offset the cost for a life-saving organ transplant or for care if a policyholder is permanently confined to a nursing home.
